1. Approve Minutes of May 14 & 21, 2018

On a motion by Sue seconded by Lee the board voted unanimously to approve the minutes of May 14 & 21, 2018.

2. Agenda Revisions if any – Tax Sale, ATV Club trail work

3. Consider signing Riddel Pond stone line ditch grant

On a motion by Sue seconded by Lee the board voted unanimously to sign the grant for Riddel Pond stone line ditch work.

4. Discuss Atherton Road/Other Class 4 Roads

The board discussed reclassifying Atherton Road as a legal trail as there is so much work to be done with the culverts and ditch work. The board tabled the discussion to talk with Mike and Terri from the CVATV Club. Mike and Terri supported the town turning this into a legal trail.

They wanted to discuss the trail work the ATV Club has been doing and other plans of maintenance. Mike was looking for town approval to improve sections of the trail system from the kiosk at Richardson Road. The board had no objections to their plans for improvement. Kathie will send Terri the property owners names and addresses as the ATV Club will have to obtain permission from the landowners along the trail.

5. Consider signing an equipment grant for a security system at town offices

On a motion by Sue seconded by Lee the board voted unanimously to sign the equipment grant for a security system at the town offices and directed Kathie to order it now and get it installed.

6. Consider joining the CV Telecom District

On a motion by Sue seconded by Lee the board voted unanimously to support the CV Telecom District in Orange and appoint Siobhan Perricone as the representative for Orange.

7. Discuss a culvert that needs replacement on Spencer Road

John explained to the board that there is a 4 foot culvert that needs replacing on Spencer Road. A trench box is needed for a project of this size and Orange does not have one so he recommends that we hire Duranleau to do the project. The board told John to call up and get a price for installation which should take one day to complete.

8. Discuss Town Garage addition

The board told John to go ahead and get quotes on tearing off the lean to and framing up the new section of the shop.

9. Discuss changes to the culvert policy

John would like to change the driveway culvert policy to plastic culverts rather than steel. The town will install them but the landowner has to pay for the culvert. The landowner will be responsible for maintenance. On a motion by Sue seconded by Lee the board voted unanimously to approve the above changes to the policy.

10. Approve Payroll & Accounts Payable warrants

The board reviewed and approve the Payroll and Accounts Payable warrants.

11. Review 2018 Budget

The board reviewed the budget.
