Town Clerk Report

Ms. Youngman discussed reimbursement for uncontrolled burns and fire reimbursement policy. She discussed this with the Selectboard. The Selectboard will discuss this at a later date.

Discuss switching uniform companies

Mrs. Eastman discussed switching uniform companies to switch to Cintas. On a motion made by Mrs. Lefebvre, and seconded by Ms. Ruff, the approval was given to end our business with UniFirst and begin business with Cintas.
